P. Judge & Sons Trucking is the transportation division of The Judge Organization. It is also the original business started over 98 years ago in 1924 by Patrick J. Judge, Sr. in Brooklyn, New York.

Our company has been providing container drayage in the Port of New York / New Jersey for over 50 years. We understand how port operations work and how steamship lines operate. When we expanded to Savannah we made sure we had the same understanding and close relationship with the Georgia Port Authority as we have had with the Port Authority of New York / New Jersey.

Capacity - Handling high volume of import and export container activity over 50,000 TEU in 2020 through the port of Savannah.

Equipment - We have over 300 of our own chassis reducing cost, increasing efficiency and ultimately allowing us to provide better service to our customers.

Our locations are all close to the port with three locations within 5 miles of the port and the ability to hold 480 containers in these yards.

Visibility and Tracking- Our Transportation Management System is completely integrated with the Georgia Port Authority's system. Allowing us to give our customer real time updates of every gate transaction, vessel change, container pickup and delivery all in one place on one platform.
